- **Title of the article** (Title: 12 Font size, Times New Roman, Bold)
- Richard Peter Hill¹, Anthony Hill² (Authors: 12 Font size, Times New Roman, Normal, affiliation with superscript number)
- **Graphical Abstract** (required for original research articles and review articles. Authors **must use one of the Graphical Abstract Templates** provided at the End of Instruction to Authors)
- **Structured Abstract** (Aims/Background, Methods (Materials/Patients and Methods), Results, Conclusion)
- **Key words:** protein, transporter (Key words: 12 Font size, Times New Roman)
- ¹*Department of ...* (Affiliations: 12 Font size, Times New Roman, Normal, Italic)
- **Brief summary:** Short text (500-750 characters – not words) with focus on originality, key findings, significance and without repeating title terms. A short summary of your manuscript is what will interest our readers.
- **INTRODUCTION, METHODS ...** (Headings: 12 FONT SIZE, TIMES NEW ROMAN, CAPITALS, BOLD)
- **Statistical analysis** (Subheadings: 12 Font size, Times New Roman, Bold)
- **Author contributions:** RPH: manuscript writing and literature search; AH: statistical analysis or all authors contributed equally to preparing the manuscript. (use initials of authors for -e.g. literature search, manuscript writing, figures, study design, data collection, data analysis, data interpretation, ...)
- **Conflict of interest statement:** exactly as: Conflict of interest statement: The authors state that there are no conflicts of interest regarding the publication of this article. (If you have no declaration to make, please write: None declared.)
- **Declaration of generative AI and AI-assisted technologies:** Authors **must always add a statement of use/non-use of AI.**
- **REFERENCES** (for correct format see Inst.to Authors)
- **Fig 1.** Changes in the. (Figure legends: 12 Font size, Times New Roman, Bold, Normal - **below the figure**)
- **Table 1.** Age of patients. (Table legends: 12 Font size, Times New Roman, Bold, Normal - **above the table**)

Manuscript structure:

- Title
- Authors (full names without diacritic or academic degree)
- Graphical Abstract (Authors **must use one of the Graphical Abstract Templates** provided at the End of Inst. to Authors)
- Structured Abstract (Exception: review articles do not have structured abstract = see Appendix to Inst. to Authors)
- Key words
- Affiliations
- Corresponding author (only full name and email)
- Brief summary
- Main text (Introduction, Materials and Methods, Results, Discussion, Conclusion, Acknowledgements, Author Contributions, Conflict of Interest Statement, Declaration of generative AI and AI-assisted technologies, References, Tables, Figures)

References in text as a letter in upper index behind the word (**without space**): ...word¹,word⁵⁻⁷.

References in text after %, brackets, abbreviation, numbers... write e.g. 5% (ref.²¹), DNA (ref.²¹), (Table 1) (ref.²¹)

P value write: P; hour write: h; second wtrite: s; litre (millilitre) write: L (mL)
